- **Prelude String Orchestra** – Beginning string players. Should have some rudimentary note reading ability and be able to play a one octave scale. Rehearses Thursdays 4:30 p.m. to 5:30 p.m.
- **Intermezzo String Orchestra** – Intermediate string players. Knows at least 2 major and 1 minor scales, one octave. Basic rhythms and note reading required (whole to sixteenth notes and dotted notes). Rehearses Thursdays 5:45 p.m. to 7:00 p.m.
- **Full Symphony** – Intermediate & advanced players. String players should be able to play 3 octave scales starting on the lowest string and at least shift to 3rd position or higher. ***First violins must audition with the conductor and should be comfortable in higher positions.*** Rehearses Thursdays 7:15 p.m. to 9:45 p.m.
